Life Solutions for Autism, LLC. Steps:

- 1) Family Assessment 2hours of goal setting, identifying circle of support, etc.
- 2) Plan for S.E.L.F. Self empowering lifelong fulfillment.
- 3) Offer plan to parents to empower them to pass on strategies to pass on to children.
 - A) Self determination
 - B) Problem Solving
 - C) Setting Goals
 - D) Celebrate
- 4) Find Resources and programs to suit each family's situation.

Works with all ages, in Oakland, Wayne counties and the Traverse City and Elk Rapids areas. Feels families need to start as early in life as possible to begin the thought process of transitioning their child to interdependent living. Is in this business to help people learn not to be reactive to proactive. Teaches soft skills to clients, coaches businesses on interviewing skills to find matches for their companies.
